CHAIR'S REPORT

It is my honour, on behalf of Branch Chair Sarjit Manhas, to provide you with the Chair's Report from the Spring Directors' Meeting.

Sarjit, as President, would not be able to represent our Branch and vote on matters so it was my honour to fulfill those duties. It was a delight to see that all Branches in the Province were able to send delegates including the one Branch that will be dissolved and merged at the end of this month. The day, March 20th had a full agenda. Our Branch Chair, Sarjit Manhas, officiated at this meeting with the same efficiency and authority as she does at our Branch meetings. The meeting was opened with the traditional and respectful two minutes of silence for deceased members.

It was noted that there had been letters sent to both Federal and Provincial Government Leaders addressing a Resolution on Retirement Security coming out of the AGM yet only Federal Government responses were received. A letter had also been received from the Pension Corp informing that our appointee's term to the Board of Trustees was about to expire. A response had been sent to inform them that Lawrence Johnson had agreed to be re-appointed for a three year term. I am confident that we will be well represented to that Board. At this time I must report that Lawrence was not at the Directors' meeting because, for the first time ever, a Board of Trustee's meeting was scheduled at the same time.

A Guest Speaker from the BC Health Coalition, Adam Lynes-Ford, introduced us to his organization and what it does as a non-profit, non-partisan advocate for public health care. The principle focus of his talk was about the Provincial Ombudsperson's reports on senior care. The second of these reports was released about a year ago with 176 recommendations. 141 of these recommendations were directed to the Ministry of Health and to date only four of

After a break for lunch and to recharge our batteries the Directors continued a discussion that had started earlier in the day regarding membership. Every Branch, whether rural or urban, is facing membership challenges and it was good to be able to share ideas together to help overcome them.

A number of very valid suggestions were put forward and I, as Membership Director for our Branch, will be endorsing and encouraging a number of these in the coming year. Ideas such as hosting a booth at the Saanich Fair (perhaps jointly with Peninsula Branch), posting notices about BCGREA in Senior's Centres, seeking help from Welcome Wagon and a number of other suggestions.

A Resolution was moved, seconded and carried to form a Committee to identify problems, recommend solutions on the issue of membership and recruitment to be chaired, subject to his acceptance, by the Membership Director of Branch 1000 Shuswap/Columbia.
