BCGREA DIRECTORS' MEETING

It is my honour, on behalf of Branch Chair Sarjit Manhas, to provide you with the Chair's Report from the Spring Directors' meeting.

Sarjit, as Past President, would not be able to represent our Branch and vote on matters so it was my honour to fulfill those duties. The day, March 23rd, had a full agenda. The meeting was opened by President Ken Pendergast, with the traditional and respectful two minutes of silence for deceased members.

Efficient use of time allowed the President to give his report before our Guest Speakers arrived.

Guest Speakers were:

- Isobel MacKenzie, Office of Senior's Advocate, Ministry of Health. Refer to the website for a warehouse of information at www.seniorsadvocatebc.ca;
- Tom Martell, Martell Insurance Services, speaking about the Guaranteed Life Insurance Plan with a supply of brochures to use at retirement seminars;
- 3. Lisa Hansen, Johnson Inc., speaking about some of the changes to the various insurance plans administered and to introduce a "Flexible Benefit Plan" (handout). It was moved, seconded and carried that the info sheet about "Thrive" be shared with members inviting input and an expression of interest that will assist Johnson Inc. and the Provincial Executive in developing this product.

A discussion regarding MSP premiums and payment through taxation was conducted. It was moved, seconded and carried that we write lobbying the government to change MSP premiums to a taxation based system. Director's Reports were concluded after lunch as was the Treasurer's Report. There were 2 resolutions discussed by the First Vice President, a.k.a. Resolutions Committee. These will be raised at the fall Annual General Meeting. The first raises the resolution from last fall regarding Cash over DCO Paying Members. It has been proposed that as an incentive to go onto DCO new members electing this option have their initial year's membership dues waived. The second resolution is concerning advertisements, advertorials and requests for member recognition articles. More information will be forthcoming in this draft policy.

Discussion then shifted to Jerry Gosling of Branch 100. This Branch is at risk of dissolving early in 2017 if more members don't step forward to serve on the Executive. Currently nine positions are being filled by two people.
