BCGREA DIRECTORS' MEETING

It is my honour, on behalf of Branch Chair Sarjit Manhas, to provide you with the Chair's Report from the Spring Directors' Meeting.

Sarjit, as Past President, was not able to attend so it was my honour to fulfill the Director's Duties. The day, April 26th, had a full agenda. The meeting was opened by President Ken Pendergast, with the traditional and respectful 2 minutes of silence for deceased members.

Guest Speakers were:

- 1. Lisa Hansen and Mark Costales, Johnson Inc. speaking about the coverages that they offer and conducting a draw for a prepaid MasterCard. Ken Pendergast was the winner.
- 2. Bob Quelch, Hearing Life Canada, speaking about his firm's recent alliance with the BCGREA and the significance of monitoring hearing loss. Note: Hearing aids are not covered in BC but there are other payment options. Exhaust all options before paying out of pocket.

A discussion regarding the Shingles Vaccine reported no changes to coverage at this time.

Correspondence included a letter regarding the conversion from Blue Cross to Green Shield Canada. Green Shield will have a speaker at the fall AGM. Travel insurance within BC which Johnson Inc. hopes to address within the next 5 days, and BC's plan to eliminate MSP Premiums which was addressed by a handout.

Directors' Reports were presented after coffee followed by a workshop focussing on Membership Recruitment and Retention lead by Reiner Augustin. A review of the 17 recommendations put forward back in 2014 were discussed and enhanced in small table groups as were next steps to move forward. Group findings will be compiled and distributed.

The Annual General Meeting will be October 18, 2017 at the Coast Tsawwassen Inn.
