

# **HEALTH BENEFITS**

### Questions about your health benefits changes? We've got answers

### Your retirement group health benefits are changing on January 1, 2022. Learn what's top of mind for members.

Changes to the Public Service Pension Plan's retirement group health benefits may affect you. To help you understand some of the important changes starting on January 1, 2022, we've answered below the most common questions the Public Service Pension Board of Trustees has heard.

### Why is the board making changes?

The board is taking action to ensure your health coverage is sustainable. The board strives to ensure changes are fair for current and future generations.

### What's changing?

Starting on January 1, 2022, there will be a new tiered formulary for the drug plan based on BC PharmaCare coverage. This will improve coverage for most prescription drugs.


Until December 31, 2021, prescription drugs are reimbursed by the group benefits program at 70 per cent.

Under the new formulary, drugs will be grouped into two levels of reimbursement:

Tier 1: drugs that are covered by BC
PharmaCare; reimbursement will increase
to 80 per cent from 70 per cent.

Tier 2: drugs that are not covered by BC
PharmaCare; reimbursement will decrease
to 60 per cent from 70 per cent.

A 12-month grace period will be provided to those retired members taking a tier 2 drug for



a chronic condition. For these members, reimbursement remains at 70 per cent during this period. The new

reimbursement for the tier 2 drug will take effect January 1, 2023. If you are directly affected by these changes, see the letter that Green Shield Canada (GSC) sent to you between October and January outlining next steps and options.

### What remains the same?

The lifetime maximum limit for extended health care coverage is \$250,000 per person.
For members who pay premiums, rates are adjusted annually. The pension plan subsidizes the cost of monthly premiums for extended health care based on your years of pensionable service. The subsidy is not guaranteed. The plan does not subsidize the cost of monthly premiums for your spouse and dependants. The plan also does not subsidize the cost of the dental program's monthly premiums.

# Who pays what amount when it comes to the deductibles?

PharmaCare has its own deductible and bases each individual's annual deductible on net family income. The PharmaCare deductible is **paid by your benefits program through GSC.** 

Your benefits program has an annual deductible of \$250, which is not related to the PharmaCare deductible. The \$250 deductible is the out-of-pocket amount you must pay in each calendar year before the plan starts paying for extended health benefits.

# Is there a list available to check if a drug is on the PharmaCare formulary?

Use PharmaCare's formulary search tool at https://pharmacareformularysearch.gov.bc.ca/faces/Search.xhtml The search tool will tell you which drugs are covered by PharmaCare. Please note the tool will not display whether your drug is tier 1 or tier 2
