Guest Speaker: Rita Innamorati – Executive Director of Volunteer Nanaimo. After Rita had a stroke in 2003 she was offered a job with Volunteer Nanaimo. Rita began as a volunteer and later became the ED. Rita described the work of Volunteer Nanaimo. In addition to working with adult volunteers, they now work with youth, encouraging them to work in the community. There is a tech program – computers that are donated to them are cleaned, up-graded, donated to others in the community who are taught computer skills. Their Christmas Angel Program is one associated with Big Sisters/Big Brothers to assist low income families, vulnerable youth, and seniors to help over 500 people. Knitters, quilters, toy makers are encouraged to donate to this program. Volunteer Nanaimo works with 16 local agencies to vet the families they serve. They have a monthly newsletter and anyone can put their name of the mailing list.
