Guest Speaker: Elderdog Canada - Nanaimo Branch-

Sharon Steevak was introduced by Lea Campbell as our guest speaker. Elder Dog is a non-profit organization assisting seniors (55+) in caring for their dogs, so they can age in place and can live in age-friendly communities. Research shows that as they age seniors find their relationships with families become more negative with focus on what seniors can't do instead of capabilities that they still have. Your dog still thinks you are fine. There is more isolation as seniors age. Having a dog is a critical part of social engagement. You have to feed, care for, and walk a dog and so stay socially connected with your community. Top five losses that seniors often face – driver's license, financial independence (power of attorney), appliances (stove turned off in favor of microwave), food choices (family provide meals), pets. Elder Dog (in BC there are 13 out of the 37 groups in Canada) is a free service to support keeping your dog in your home – shopping and walking services, temporary foster care, re-homing if necessary. If you are interested in volunteering with Elder Dog then visit their website www.elderdog.ca and see how you can become involved.
