New Business – Executive Reports

Chair: 1. Kirstine Hill, Chair, attended a Zoom meeting for Branch Chairs on September 3rd

- Kirstine reported on the Recruitment Initiative between our Branch 1000 and Branch 300 in recruiting and supporting Golden BCGREA members.
- Kirstine also reported that we have a meeting schedule of 4 times a year with guest speakers such as Kathryn Vennard, lawyer, who spoke on Wills and Estate Planning.
- During the meeting the results of the volunteer recruitment from the member survey was discussed. Many branches didn't get names sent to them and that was to be followed up. Our branch did get names and JoAnn Fowler, vice chair, followed up with those individuals.
- A name change for BCGREA was discussed. This was also part of the membership survey.
 The goal of a name change is to reflect the diverse membership of the BCGREA. More research needs to be done on membership concerns, cost and the Societies Act.
 - 2. On October 15th, 2025 there will be an "Extraordinary General Meeting" via Zoom followed by a Directors Meeting. JoAnn Fowler and Kirstine Hill will attend as voting delegates but all members are welcome to observe proceedings. Information on this went out from Central Support on September 3rd. Topics for discussion include a resolution to increase dues, a resolution related to the position of the immediate Past President and a motion to approve the requests for annual honorariums.

Earlier this spring, at the BCGREA AGM, Elaine Koskimaki (Secretary) and JoAnn Fowler(Vice Chair) were approached by two members of the Rocky Mountain Branch Executive. They knew that our Branch had members living in Golden and they did as well and that neither group was currently meeting. Travel from Golden to either branch to attend meetings is not feasible. It was hoped that encouragement and support could be given so that they would get together and benefit from having meetings. We also discussed on moving forward and how the committee could support them to start meeting.
