**Resolution From Cariboo Branch 1700**

re: Proposal For Increasing BCGREA Membership

Whereas we are in the age of economic and political disruption both internationally and in Canada; Whereas we have seen in the province of Alberta, the government has fired the public service pension investment board, and appointed a political czar to oversee investment decisions; Whereas the current and future health of our pensions is paramount for both contributors and those receiving pension benefits; and, Whereas the BCGREA membership numbers need to dramatically increase to better reflect those individuals receiving Public Service Pension Plan benefits; Therefore be it resolved the BCGREA consider a low fee or “no fee” membership for Pension Plan contributors, prior to their retirement and receipt of Pension Plan benefits, and check off of regular membership dues upon receipt of benefits; and, Be it further resolved the BCGREA Executive in consultation with membership input prepare Constitutional amendments to permit such changes in membership for the consideration of the delegates to the next AGM.

**Proposed Bylaw Amendment for Consideration at the April 2025 BCGREA AGM**

Whereas, the current language of Article 23 BCGREA Bylaws is in conflict with the provisions of the BC Societies Act,

Therefore be it resolved that the current language of Article 23, be deleted:

23 (a) A resolution proposed at a meeting must be seconded, and the chair of a meeting may not propose a resolution. (b) In the case of a tie vote, the chair does not have a casting or second vote in addition to the vote to which he or she may be entitled as a member, and the proposed resolution does not pass.

And replaced with:

23 Resolutions that follow the requirements of Section 81 of the BC Societies Act may be submitted for consideration at an Annual General Meeting, Special General Meeting or Directors' Meeting.

**President – Brian Green**

What we have been doing in the past six months is to figure out where we are and start moving forward to ensure we remain relevant and of use to our members. As I write this, the results of our recent membership survey are being analyzed. We had almost 1/3 of those who received an invitation to respond, take the time to do so. Thank you - this provides us with some strong empirical information that we can factor into our decision making.

While it’s too early to comment in any depth on the survey, it is abundantly clear that you value the role of the BCGREA in supporting and advocating on behalf our pension plan and similar

ones for all Canadians. Given the economic turmoil going on, it's clear that pension funds such as ours are being looked at by politicians as a way of meeting their agendas.

As I have said before, we need to remain vigilant about this, raising our voice when needed and supporting efforts to ensure that both decision makers and the general public understand the nature of our pensions. Our pensions are primarily self-funded and a considerable source of stable income within communities.

We are also working with the other public sector retiree groups in BC to ensure this message is out there. Our keynote speaker at the AGM on April 30th will focus on the role of investments in ensuring the stability and resiliency of our plan. I am a broken record on the need to keep up membership. Fundamentally, the larger our membership, the more we get heard. It's that simple. I encourage you to reach out to your former colleagues and invite them to join us or at least look at our website. There are no more in person pension seminars, so our opportunities for reaching those retiring is limited.

We are working to enhance our visibility by developing a communications strategy that corresponds to how these folks receive their information, such as social media, YouTube or equivalent. I recognize there is considerable discomfort among some members about operating in this space for a variety of reasons, but I firmly believe we need to do so in order to reach this audience. Our plan will be deliberate, cautious and results focused. To this end, we will be working with a new communications firm to support us along with the other pension associations in producing some videos

– the first of which will focus on recent retirees asking what it is that surprised them about retirement. We know that loss of a sense of community is often felt by people upon retirement, and we are committed to ensuring that members have a variety of tools to stay in touch, including our branch meetings, social events and webcasting. The other big-ticket item we know that often surprises people at retirement is the loss of benefits, including cellphone plans, travel insurance and most importantly, extended health and dental benefits.

If a pending retiree doesn't pay attention to these, they can be in for a rude awakening. We hope to advise them of upcoming changes so they can make smart choices and where possible, provide some affinity deals for them to consider. Our extended health and dental plans are optional at the discretion of the Board of Trustees.

They are financially capped by the Board and focus on core services with few enhancements. They are not negotiable and the BCGREA has no say in how they are set, other than to pass on the concerns of members regarding the adequacy of coverage – sometimes we get results such as the inclusion of shingles vaccines. There needs to be greater clarity around the role of the claims' administrator, GreenShield. They are simply that, an administrator. Greenshield does not set the levels or types of coverage. For those who pine for "the good old days, a change of plan administrator would not change this. There will be a specific focus on the extended benefit plans at our upcoming AGM, which you can stream online by getting a Zoom link from [info@bcgre.ca](mailto:info@bcgre.ca).

As well, the Pen newsletter will be having coverage on this as well. I usually end by encouraging comments and making a plea for volunteers. On that front, I have very good news. As part of the survey responses, a significant number of members indicated a willingness to volunteer on provincial level matters as well as the branch level. This is great news and we will be in touch with you. To my fellow table officers, branch officers and volunteers, thank you. To my fellow table officers, branch officers and volunteers, thank you. To all of you – stay strong, be healthy and enjoy the spring and summer.

### **First Vice-President – Wilf Brodrick**

It has been my distinct pleasure to serve as First Vice-President since being elected at the AGM last Fall.

One of my duties has been to assist the President. In this regard, we have had several meetings with representatives from the other BC Public Sector Pension Plans. In addition to the BCGREA, the other groups are the BC Retired Teachers' Association (BCRTA), BC Municipal Pension Retirees' Association (BCMPRA) and the College Pension Plan Retirees (CPPR). I believe we have made a good start on working together to address issues common to all four organizations.

Another part of the first Vice-President's duties is to Chair the Constitution and Bylaws Committee, and by default, the Resolutions Committee. This is my first General Meeting since finding myself in this role. Unfortunately, the job of becoming accustomed to my role as a Table Officer has meant that I haven't been able to devote as much time to these duties as I might have wished. If I continue as First Vice-President, I hope to have the Constitution and Bylaws Committee meet often enough to ensure that our Constitution, Bylaws, Policies and Procedures are kept in compliance with the Societies ACT while meeting the needs and requirements of the members. I would like to thank George Bowden, Carol Paulson and Merrilee Ashworth for agreeing to serve as members of the Committee and I look forward to working with them.

I also wish to thank President Brian Green for continuing my appointment as a General Vice-President of the Council Of Senior Citizens Organizations of BC (COSCO BC). COSCO BC has a very important role representing and advocating for issues important to seniors in BC, and BCGREA Delegates to COSCO BC are an important part of its continuing success as "The Voice of BC Seniors".

I would like to acknowledge the other BCGREA Delegates to COSCO BC, particularly Patrick Harkness, Jean Sickman, Denis Ishikawa and Edna Park. In addition, Renee Poley from the Langley/Surrey Branch also deserves recognition, as she has been appointed to fill the remainder of former COSCO BC Treasurer Stéphane Lapierre's term ending in 2026.

In my role with COSCO BC, I have remained very busy, serving as Chair of the Finance Committee and Chair of the Nominating Committee, responsible for COSCO BC elections. I also serve on the Housing Committee and the Membership and Fundraising Committee.

COSCO BC is planning its 75<sup>th</sup> Anniversary Conference to be held on October 4<sup>th</sup> and 5<sup>th</sup> of this year at the **Sheraton Vancouver Airport Hotel, Richmond, BC**. The theme of the conference is **Human Rights and Ageing - Advocating for an Equitable Future**. Like previous COSCO BC Conferences, there will be interesting and informative speakers and panels. ### **Membership Secretary's and Central Support Report – Al Barclay and Jodine Ducs**

The change for the AGM to be held in April has reduced the number of accomplishments to report in the last six months. On April 11, 2025, the BCGREA had 10,972 members, which is a decrease of 325 members or nearly 3%. Quite a few members have passed away and we have also deleted members that we have lost contact with and those who have not paid their membership dues. We want to reverse this downward trend and it will be helpful if current members reach out to former coworkers and invite them to join. As a reminder, the first year's membership is free, so they can test the benefits of membership and see if they like it.

One of the biggest initiatives I was involved with was the member survey in March. It took a lot of time and effort to develop the questions so that we should get meaningful feedback about the members' preferences for moving forward. I would like to thank the 10 people who served on the design committee as well as all the members who submitted their survey responses. Dr. Richard Brown of CDR Business Diagnostics will be presenting an overview of the survey results at the AGM, but a couple highlights are that 2,794 surveys were submitted for a response rate of 32.17%, which makes us confident that the information is accurate.

Another positive result of the survey is that a number of people expressed interest in volunteering for positions at the provincial or branch levels. We will be reaching out to those people to ensure there is an opportunity to assist and to answer questions they may have about the various roles.

The new Cowichan Valley branch appears to be off to a positive start. A core group of willing volunteers stepped forward to fill the branch executive roles and have designed a poll that will ask their members what their preferences are with respect to gathering frequency, topics, locations and activities. It is good to see the level of enthusiasm that is being generated; I am confident that this branch is well positioned to build momentum. I want to thank Al Coccola for his dedication and direction as the mentor for the branch.

Most people's least favorite job is asking for money! This year, Central Support offered to assist branch volunteers with the collection of cash dues from our Associate members. Our database software, Findjoo, has the ability to issue electronic notices and emails – providing a much easier way to collect the annual dues.

We have also added a new email preference: BCGREA Athletics. This preference will ensure members interested in the 55+ BC Games and other athletic opportunities are kept apprised.

Finally, have you checked out the BCGREA [Events Calendar](#)? It's a great way to see what's happening across the province and to confirm your own branch's upcoming event.

As always, it is a pleasure to work and serve this great Association.

## **Recruitment & Retention Committee Report – Bonnie Billington**

In discussions with non-government Human Resources departments, Brian Green reports that a significant number of their members are unaware of their eligibility to join our association. Hence the proposal to change the name of the BCGREA to attract all potential PSPP recipients.

The 'Open House' in Duncan on October 8, 2024 sparked the formation of BCGREA Branch 2600 Cowichan Valley that is now up and running, mentored by Al Coccola. The new executive put together a member survey with help from Al Barclay to elicit membership input on meetings and activities. Plans are to hold their first meeting in May and the second in July.

A point of discussion at our last R & R meeting on March 20th involved an offer by the Table Officers to visit branches throughout the province. To maximize efficiency, Brian Green suggests branches take the initiative to coordinate with others in close proximity. Although in-person meetings are preferred, using zoom for remote areas would be an option.

The second All Branch Chair's Meeting was held on March 5th on zoom. The next meeting is scheduled for May 7<sup>th</sup>. These meetings provide a forum for Branch Chairs to share experiences and have been well received. Discussion on the definition and purpose of honorarium payments to branch executives i.e. recognition of meritorious service as defined by the branch. The process requires participating branches to submit a resolution to the Resolutions Committee for approval by a majority vote of authorized delegates at the BGGREA AGM or Directors Meeting.

A list of potential speaker topics is posted on the BCGREA website to assist branches in selecting topics of interest for their meetings. Members are encouraged to contact the R & R Committee with any new ideas: [bcgre.ca/recruitment-and-retention](http://bcgre.ca/recruitment-and-retention) The Merchandise Committee currently has 21 Branch Contacts listed on the BCGREA website under Merchandise, with links to generic emails for each. In keeping with the Canada First Movement, the merchandise page now includes the country of origin for each product. New offers will be sent out to members who have chosen 'BCGREA Merchandise' under 'Email Out' on Findjoo. There will be a couple of new items on display at the AGM.

The 55+ Games for 2025 will be held in Nanaimo from September 9 –13; now open for registration. The option to receive information about BCGREA Athletics is now available on the BCGREA website members page when new members complete the Communication Category Descriptions. To choose this option, existing members need to update their member profile.

The R & R Committee awaits the outcome of the most recent membership survey in determining the membership's current interests, priorities and willingness to volunteer at the branch and /or provincial level.

## **Treasurer's Report – Johanna Morrow**

I am pleased to present our 2024 financial statements (pages 2-6) and the 2025 budget (page 7). Traditionally these statements compare the reporting year with the prior year. Because we changed our yearend in 2023 from June 30th to December 31st, annual comparisons were not available and instead these statements break out 2024 spending for the provincial level (centralized spending) and the branch level (23 provincial branches). Next year the statements will again compare the current year to the prior year.

We ended 2024 with a small surplus of about \$34,000 which, along with a healthy year end balance, allows us to fund the 2025 member survey, expand our association newsletter (The PEN), absorb increasing operating costs, and continue to support member programs. There is no imminent need to raise member dues.

While our overall cash is sufficient to fund our spending plans for the coming year, it is still unevenly distributed between the various branch and provincial level bank accounts. Therefore, rather than allocate the same proportional share of member dues to every branch, we will continue to use a funding formula that ensures those branches without surplus funds will have at least \$10 per member to fund their annual operations. And a special thanks to Kathy Torhjelm who, along with her many duties as our Association Secretary, was also my second signer/approver for all provincial level expenses.



## British Columbia Government Retired Employees' Association 2024 Financial Review

**Purpose** – To provide a reasonable assurance to the membership that:

- dues and other contribution for the Province have been deposited to the Provincial bank account;
- expenses are appropriate, properly approved and recorded; and
- Provincial bank balance reconciles to the treasurer's financial records.
- Association's financial statements correctly represent the financial position of the Provincial Level plus the 23 Branch Levels.

**Process** – The financial review will be conducted by a committee of two people that have not been involved in the financial transactions at the Provincial Level. The committee will review the records and sign off below. Not all transactions need to be reviewed. The committee can randomly select a sample of about 10% of the transactions or select one or two months to review in detail.

✓	<b>The committee will check for the following:</b>
✓	All Provincial Level funds are kept in an approved financial institution and there are two authorized signers on the account.
✓	The January 1, 2024 Provincial Level opening balance matches the prior year's closing balance
✓	The December 31, 2024 Provincial bank statement reconciles to the Provincial Level records.
✓	Based on the sample entries reviewed, there is supporting documentation for the Provincial Level income and expenses.
✓	Based on the sample entries reviewed, Provincial Level financial records appear to be complete and up to date.
✓	Based on the year-end financial information provided by the Branches, the Association's total income, expenses and year end cash balance includes the income, expenses and cash balances reported by every Branch
✓	The Association's total balance on January 1, 2024, plus all funds received, minus all expenditures, equals the Association's total balance on December 31, 2024.

**Reviewers' Statement:**

## **Trustee for the BC Public Service Pension Plan Report – Johanna Morrow**

I am honoured to have been appointed by the BCGREA to continue as a Trustee of the BC Public Service Pension Plan (PSPP) Board of Trustees for another three-year term to March 2028.

I'd like to clarify the trustee role. Although appointed by the BCGREA, I do not directly represent our association. Nor do any of the other trustees represent their appointing bodies. All 14 PSPP trustees have a fiduciary duty to represent and act in the best interest of all plan members (active, inactive, and retired). Direct advocacy on behalf of the BCGREA rests with the president. Many thanks to our president, Brian Green, for being a strong advocate for maintaining and improving retired member benefits. He works closely with the Board's chair and executive director to raise our concerns in areas such as improving post retirement group benefits and communications.

Our pension has continued to perform very well. The most recent valuation showed a funding ratio of 113%, meaning the plan's assets exceeded its liabilities by \$4.5 billion. But as we follow the imposition of tariffs and other news from our southern neighbour and see the political and economic fallout in Canada and around the world, we have very understandable concerns about our pension plan's future investment performance. The keynote speaker at this year's AGM is Harlan Enns, Director, Client Relations, BC Investment Corporation. Harlan's presentation "Challenges and the Strength of our Pension" will address these concerns and provide some insights and reassurance on how our plan is designed to withstand challenging economic times.

On a personal note, last year I achieved the designation, Master of Trust Management Standards (MTMS) from the International Foundation of Employee Benefit Plans. This was a four-year program for advanced level multi-employer, public sector and corporate plan trustees. Every PSPP trustee also participates in annual workshops and conferences to grow their pension knowledge and expertise.
