More news and announcements:

Important notice: The process of branch delegate representation and voting at Provincial BCGREA meetings needs updating as discussed at the Directors' Meeting and Delegates' Workshop in Tsawwassen on April 25-26, 2023. Subsequently a *Delegate Formula and Voting Committee* was struck, but no consensus was reached on the proposals put forward including:

- Each branch sends a chair plus a single delegate *regardless of membership numbers*. Under this option the total votes would be 53 including table officers. *or* -
- Each branch sends a chair plus 1 delegate for every 500 members (or portions thereof) for a total entitlement of 64 votes. As discussed at the Branch 800 General Meeting on Sept 19th, our executive and AGM delegates support this proposal as the most fair and equitable representation of the membership, considering branch numbers range from 114 members in the smallest branch to 2746 members in the largest as of April 8, 2023.

Evidently a recommendation will be put forward at the AGM in October that an email will be sent to all members for their input on the two leading suggestions. Please consider carefully. We support the one delegate in 500 formula as the most democratic representation.

Disability Alliance of BC (DABC)

In May 2021, the BC Government passed into law the **Accessible BC Act (ABCA)**. DABC continues to engage with the Government to ensure implementation will be meaningful and create a positive change in reducing barriers for people with disabilities in our province.

On September 2, 2022, a new Regulation under Part 3 of the ABCA came into force which required more than 750 public sector organizations to establish:

- 1. An accessibility committee
- 2. An accessibility plan
- 3. A tool to receive feedback on accessibility

There is further criterion on composition of the committee (which must include people with disabilities and indigenous people). The plan and the feedback tool must also be available to the public.

The public sector organizations that must meet the requirements include municipalities, regional districts, Post secondary educational institutions, public libraries, municipal police departments, Francophone school districts, independent schools, School Districts, Heath Authorities, Public Sector board, agencies, tribunals and commissions.

The majority of these agencies had a deadline to meet these requirements **by September 1, 2023.** Health Authorities, some boards, agencies, tribunals and commissions have an extra year to comply by **September 1, 2024.**

DABC received government funding to assist organizations in meeting these goals. They have been conducting presentations, workshops and meetings with the

organizations on the three requirements. They also established resource website: BC Accessibility Hub and an Accessibility Toolkit. These can be accessed at:
