# **Letter from the Ministry**

When you think about it, deriving amusement from another person's misfortune is a rather unattractive aspect of human nature. But then there's a "but...".

In previous little tales I've told of a time I had stopped for some refreshment on Loch Lomondside while the A82 was being widened and straightened. I had a view of the parking lot and saw a works van pull in and about half a dozen workmen pile out. With the back doors open they made a ramp with a 2 by 10-inch board. One of the workers manhandled a motorcycle out from among the parked vehicles and sat astride it, obviously going to ride it into the van. I took my eyes off him for a moment and when I looked again the bike was on its side, the would-be rider was writhing on the ground clutching his right ankle and his workmates were helpless with laughter.

Another such incident happened when one of my colleagues in Paisley, Scotland, bought himself a motorcycle, a shiny black helmet, black raingear and gauntlets. When taking his road test, the examiner told him to drive round the block and when he returned, he was to perform an emergency stop when he saw the examiner raised his clipboard. When Duncan returned, the examiner was lying in the street being tended by some bystanders, and a black clad motorcyclist was explaining to a police officer "Ah seen him waving at me and then he stepped right oot in front o' me!"

Twenty some years ago I was walking down the main street in my hometown. Three men were standing together, two of whom were chuckling about something and the third had an unhappy look on his face.

Two of them I knew. Mr. Cameron was one of the town's butchers, he'd been a couple of years behind me in school. The unhappy one was named McPhee, he was closer in age to my sister, who was 8 years older than me, and had the nickname "Nifty", (My hometown was fond of giving people nicknames.)

I was introduced to the third man, Mr. McMillan, who was a member on the Community Council. The other two urged Nifty to show me his letter.

The letter was from the Ministry that paid Nifty his old age pension. It had come to their attention that Mr. McPhee had died the previous January. His pension had been stopped, and they wanted Mr. McPhee, "or your agent" to repay the pension paid to him since January. (This would've been in March).

As I handed Nifty back his letter, I said to him "Should you no' be lying down?" (A posture often assumed by the dead).

Most are familiar with the terms "looking daggers" and "if looks could kill". My mother had a word she used to describe an extremely scathing look of disapproval, "a sinker".

Nifty never said a word, he just gave me a sinker. Comment enough.
