The meeting was called to Order at 10:00 with Maurice Davidson in the chair and 22 members present.

Linda Jones introduced our guest speaker Major Paul Trickett of the Penticton Salvation Army. After a quick summary of the Salvation Army's history, we were given some interesting current facts.

The Salvation Army is present in 400+ communities across Canada.

They also have a presence in 134 countries around the world. Four nations: Canada, USA, New Zealand/Australia & the United Kingdom are supporters of the 134 countries.

The mandate of the Salvation Army is "Help those that are helpless"—something that is being seen more and more these days.

The Penticton Salvation Army serves people throughout the entire South Okanagan and east to Trail. The Red Kettle Campaign, manned by volunteers raised over \$144,000.00 in 2023. Every dollar donated in this campaign goes back to the Food Bank Program.

Major Paul gave a very interesting presentation on food banks in BC—and how they operate in Penticton. Food insecurity has increased dramatically since COVID for many demographics in our society. (An interesting fact was that a survey completed indicates that less than 15% of people utilizing the food bank at the Salvation Army were unhoused.)

The cooperation between the various food bank organizations in Penticton, as well as the generosity of the grocery stores and other food providers was interesting to learn about. As well, the partnerships with farmers in the area was discussed—no food gets wasted. Meat that is donated by the grocery stores goes into the walk in freezer until it is needed to be distributed. What cannot be consumed by humans is given to farmers for their animals. In exchange the food bank is provided with food items such as fresh eggs.

The Penticton Salvation Army has partnered with the provincial government in preparing for Emergency Disasters that are happening more often. They are waiting for a new service vehicle to assist in providing food to front line workers as well as those displaced by natural disasters. In addition, some supplies are being stored at the facility in Penticton.

Pre-COVID the Salvation Army had approximately 320 volunteers. Currently they have around 140. (Volunteers have 'aged out' or left for other reasons.) The Salvation Army has a need for volunteers for many community projects that they support throughout the South Okanagan.
