## 8. FINANCIAL REPORTS

- The Treasurer, Roland Oliynyk advised that an application for funding will be submitted to BCGREA headquarters in the amount of \$8780.00 for 2024 projected expenditures.
- Updated balance sheet and income statement provided by the Treasurer as attached noting that all items are balanced.
- It was noted that the Branch 1500 Treasurer currently serves on the Finance Committee for BCGREA provincial administration.

#### 9. MEMBERSHIP REPORT

- It was noted that by the Branch 1500 Membership Chair, Kim Applegate, that there are currently 481 members of which 401 are BCGREA members and 80 are spousal members.
- There have been no new memberships since October and 2 members have chosen to leave.
- Regretfully, there are 5 members most recently reported as deceased. In other branches, it was noted there is a "welfare person" assigned to extend Branch Executive condolences of deceased members to next of kin. If agreed, Grace Kramer will be asked to take on this role for Branch 1500.
- As previously discussed, in January 2024 all Branch 1500 members will receive membership renewals (unless opted out) with deductions in the amount of \$20 applied to February pension plan payments.
- There was a Report to Members issued providing highlights from the Oct 23, 2023, Members Luncheon along with a Holiday Greetings message on behalf of Branch 1500 Executive.
- Lastly, it was noted that there are "self-serve tools" available for all Members to adjust their profiles including updated email address on the "FindJoo" app found here on the BCGREA site.

#### 10. OLD BUSINESS

- Branch 1500 Membership Event was held at the KF Centre for Excellence on Monday, October 23, 2023, at 11:00am which was well attended with highlights as follows;
  - To summarize, expenses incurred for the event reflected \$6555 and \$793 in related income realized. Branch 1500 will request \$8780.00 from BCREA head office to offset membership event expenses incurred. It is anticipated that receivables will be forthcoming in Spring 2024.
  - Branch 1500 Membership Meeting in mid to late Spring 2024
    - Vernon meeting to be held at a previously hosted public location (e.g., library) and Kelowna meeting to be held at the BCGEU office.
    - Further details along with the Meeting Agenda will be provided in early Spring 2024.
  - Annual General Meeting (AGM) of the BCGREA October 18, 2023
    - It was noted that, in attendance, each Branch is permitted the Branch Chair along with two delegates (Treasurer and Membership Chair).
    - As previously noted, the Branch 1500 Treasurer is appointed as a member of the BCGREA Finance Committee. There was a Finance Committee meeting held on Wed, Nov 29 with the following agenda items covered:

      - Compliance measures aligned with BC Societies Act and Income Tax Act
      - Travel Policy implementation and enforcement measures
      - Insurance requirements and review
