- Green sleeves are supplied by Fraser Health programs. Content is specific to Med Watch program.
- Green sleeves are available from: 604-510-5081; info@medwatch911.ca; Langley Division of Family Practice; and www.Medwatch911.ca
- Our health system is designed to keep you alive
- But the Medwatch allows you to specify your own personal wishes, such as:
 - Goals and priorities
 - Your personal fears of the health care system
 - What do you not want done to you
 - What are you willing to go through for more time
- PU COPIES IN THE ENVELOP. NOT ORIGINALS. THE PACKAGE MAY NOT COME BACK FROM THE HOSPITAL WITH YOU.
- Put the envelope on your fridge
 - If not magnetic, put a green dot of the front door. The second green dot is on the outside of the door
- Essential information
 - Who do want to make medical decisions for you. Fact half of the people over 65 in the hospital need to have someone make a medical decision for them; 25% need to have someone make all the decisions for the patient
 - FORMS
 - Enduring power of attorney for financial decisions only. Need 'enduring' so that if there is loss of cognitive awareness. Reuires notary/lawyer to sign off on
 - Representation agreements
 - a) 7RA some health care like move to a facility, but not end of life
 - b) 9RA all including end of life care decisions
 - requires 4 signatures subject, representative, plus 2 witnesses
 - o temporary substitute form list of family members. Can also list people that yu don't want to make decisions for you.
 - o Fraser Health
 - MOST form, requires doctor's signature and date. Outlines scope of treatment for advanced care plan. Has bar code so any Fraser Health facility can access the information
 - No CPR form aka DNR. Requires doctor's signature and date
 - To be renewed annually
 - How to talk to your doctor about end of life care talk about the 4 questions above
